

TYPES OF SUBSCRIPTIONS

SINGLE: Covers any single, widowed or divorced person 18 years of age and older.

FAMILY: Entitles a husband, wife and any children under 18 years of age to this coverage. Full-time college students up to age 23 are covered in a family subscription.

GUEST: This covers anyone who is not a resident of the Millerstown Service Area, and is a guest in your home and requires the use of the ambulance. This person would not be billed for the services. Membership in the ALS is also provided when you take this subscription.

FIRE DEPARTMENT: This subscription is **required** for all active fire department members and is available to the public as a social subscription. This subscription does not qualify you to be a firefighter. To become a firefighter, further training and certifications by appropriate personnel are required.

PRIVILEGES OF THE SUBSCRIBER

Subscribers are entitled to **5** emergency ambulance trips up to 100 miles each round trip. Should a trip be over 100 miles, a fee per mile will be charged for additional mileage.

THIS SUBSCRIPTION NO LONGER COVERS ROUTINE PATIENT TRANSPORTS.

ADDITIONAL SUBSCRIPTION INFORMATION

This subscription is honored for EMERGENCIES ONLY. In the event Millerstown Ambulances are not available, another ambulance will provide service.

Each Ambulance reserves the right to have miscellaneous charges that are not covered by this subscription.

WHY SHOULD YOU SUBSCRIBE?

Subscribers will incur no additional expenses for use of our emergency service. Most insurance plans do not cover the full charge of ambulance and paramedic services, leaving you with balance bills, co-insurance fees and/or deductibles. Your subscription will cover any unpaid portion of your emergency services, except those required by law or regulation.

Non-subscribers are charged an average **\$700** for Ambulance Service and **\$1000** for ALS Service per call.

General Membership Information

The 2012 Millerstown Fire Department Ambulance League subscription drive will again include coverage with West Shore ALS (Advanced Life Support). Our closest West Shore ALS provider is based in Duncannon. When a life threatening call is received by the Perry County 911 center, Millerstown Ambulance and ALS are dual dispatched. The Millerstown Ambulance will respond with at least one EMT and a trained driver. ALS consists of Paramedics that are trained with additional skills which cannot be provided by EMT's or First Responders. If the Perry County ALS unit is not available, an ALS unit from Dauphin, Cumberland, Juniata, or Snyder Counties will be dispatched to assist. If you are a member of the Millerstown Ambulance league, ALS services will also be covered at no charge. ALS services **DO** conduct 3rd party billing. If you are a member and have insurance, your insurance carrier will be billed. If you are a member and do not have insurance coverage you will **not** be billed for Millerstown Ambulance or ALS services.

NOTE: If you receive a check directly from your insurance company for Ambulance Services it is to be forwarded to the address on your bill.

***All subscribers who are planning to use Lewistown Hospital for their main hospital should contact Port Royal EMS at (717) 527-2932 for a ALS subscription. This subscription WILL NOT cover Port Royal EMS ALS services.**

Policy Change:
All subscriptions received by December 31, 2011 will receive a \$10 discount. After December 31, 2011 single and family rates increase by \$10.
